This pathfinder is intended to serve as a ready reference tool to the general public at the San Jose Public Library and King Library. Patrons of the Peninsula Library System also have access to the resources listed here. The users of the library are ethnically diverse and come from many different backgrounds and include students of San Jose State University.

Recently, the subjects of animal rights and animal welfare have gained public attention as vegetarianism, special diets, animal welfare, advances in biotechnology, and pet ownership have gained momentum. In the Bay Area, a cradle of political activism, there are several organizations that promote animal welfare, fighting for eliminating cruelty towards animals and advocating for a more humane treatment of animals.

This ready reference pathfinder is intended to provide activists and other library users alike with a place where to get educated about the animal rights movement in the United States through a variety of print and electronic resources. Although the libraries have a vast amount of information, they are hard to find and take a considerable amount of time to research. 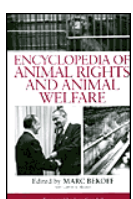
