Internet Accessibility of Depository Libraries in the State of Michigan Library of Michigan

Conclusion: The library's website is merged with the one for its institutional parent: History, Arts and Libraries (HAL) which makes it for a very informational but also a very busy, and at times confusing, website. The design is aesthetically pleasing, modern, and pages appear to be dynamically generated.

From the main library page, locating government information is easy as a link to the Government Documents section is prominently featured under services. It can also be accessed through the menu choices Services and Collections and then Government Documents. Both point the user to an overview of the government depository programs as well as to government links within the library's website or electronic library. The number of available links for federal government information is scarce and only listing GPO Access, American FactFinder, US Government & Politics database, and the University of Michigan's Government Documents Center. This last one which is reviewed in this paper under selective depository is indeed a rich resource. However, it is surprising that the Library of Michigan as the regional depository has not built its own online government information collection.

It must be noted that demographics and population information specific to the community served by the library is not listed. The information retrieved is from the U.S. Census, links to which are provided in the library's website.

Information on Michigan's State Government is plentiful. An involved search under Workplace and Education Tools and later State and Local Governments offers an organized pathfinder to all state government information available within the parent website with some links pointing to the library's website.

Conclusion: From the main library's website the user can easily reach the Government Documents Center (GDC). The GDC a central reference point for government information, whether local, state, federal, foreign or international. Its pages are a reference and instructional tool for any type of information related to government, political science, statistical data, and news. Besides being a selective depository for U.S. Government, it is also a depository for the State of Michigan, the United Nations, the Food and Agriculture Organization of the United Nations, the Asian Development Bank, the South Pacific Commission, and the Government of Canada.

What the GDC lacks in eye catching design it makes up in an astonishing volume of information available. Once in the main page, the user can navigate through any of 8 sections: Government, Related Disciplines, Class Assignments, Special Projects, Databases, Documents Center Information, University Library, and News. Each section is further subdivided in categories which aid the user in conducting a targeted but thorough and detailed search. At the top of the page the most used links have been listed offering the user who knows what she is looking for a quick way to navigate the site.

This website is a veritable cornucopia of government information and its navigation is intuitive which turns government research into a fun activity and a true pleasure. It is also very well organized and in the author's opinion, it is better suited to be the website of a regional depository than the Library of Michigan's.

Conclusion: This website is simple, both in content and design. Information on the depository is not easy to find and not abundant. The navigation is straightforward.

The content is richest as it pertains to legislature and statutes, and courts and cases, with state legislative information almost tripling federal information. The section in Additional Resources for both legal and government documents is more extensive. Links to pertinent databases are listed in this section.

It must be noted that the demographics information specific to the community served by the library is not listed in the library page. The information listed is extracted from the main university's website. The population figure is retrieved is from the U.S. Census, a link to which is provided in the library's depository website.

Overall, it is a satisfactory research website for government documents.
